

This agreement is for persons or entities who will actually use the water when it is available. In consideration of the District making the water available, I agree:

- (1) To purchase, or cause to be purchased, one Benefit Unit for water service a unit price of determined by the Board, plus any additional costs of installation as determined by the District's maintenance contractor. Under no condition will construction begin without full payment of the unit fees plus any additional construction costs. The water service supplied by the District shall be for the sole use of the undersigned and the undersigned agrees that they will not extend or permit the extension of pipes, or a garden hose, etc for the purpose of transferring water from one household to another, nor will they share, resell, or sub-meter water to any other dwelling. Each meter service shall supply water to only one residence or business establishment located on the property listed above.
- (2) To pay a minimum monthly charge for each water service from the time service is made available by the District, and pay for water used at the rate set out in the rate schedule adopted by the Board of Directors. Failure to pay the minimum monthly bill until connection is made from meter to dwelling will result in a "disconnect".
- (3) To use the water in accordance with Rules and Regulations as established by the District and to promptly pay for the water at the applicable schedule of rates. Any changes made in the minimum monthly charge or rate schedule by the Board of Directors of the District shall become a part of this agreement as though fully set out herein.

- (4) If water service is discontinued for any purpose, reconnection shall be subject to the Reconnection Policy set out in the Rules and Regulations.
- (5) The undersigned, if registered owner of real estate, agrees that he will grant the District a license to enter onto the property listed above to access the water lines over, under, or across any real property bounding the planned service lines of the District. The undersigned hereby grants District the right, at all reasonable times, to enter upon the property listed above to: (i) read and test meters; (ii) inspect piping and to perform proper maintenance and operations; (iii) remove its meters or equipment; or (iv) for any other purpose the District deems necessary, including but not limited to, any emergency situation as determined by the District.
- (6) The laws of the State of Oklahoma, the Bylaws and the Rules and Regulations of the District, as presently existing, and as may be amended from time to time, are made a part of this agreement as though fully set out herein. See also "By Laws" on page 3, Article V. section 3, 4, and 5 and "Rules and Regulations"
- (7) It is further understood that if the board rejects a new service application at the time of applying for service the deposit I put down for service will be refunded back to me. **If Accepted, the Member Benefit Unit Cost becomes Non Refundable.**
